Clinic Expansion



In April MHLHC expanded from hosting two volunteer lawyers per evening clinic to hosting three. This change allows us to serve twelve clients per clinic as opposed to just eight. So far we have seen wait times for appointments decrease, and hope that in the future we will observe fewer no-shows as clients are not required to wait as long for their appointments.

April 22nd was Law Day in Alberta! Law Day is a national event to celebrate the signing of the *Canadian Charter of Rights and Freedoms*. Various events took place at the courthouse and provincial building. The Medicine Hat Legal Help Centre participated with a booth to promote our services and raise awareness of legal assistance in Medicine Hat and surrounding area.



Alberta's Law Day also provided a service called Dial-A-Law, during which individuals could call and speak to a lawyer for free for 15 minutes. This year 178 individuals were assisted. This is a great service for Medicine Hat residents to note for next year!
